

Shaundra Clark -Opening Session Speaker

Shaundra Clark, a native of Missisippi, has served in the public housing industry for nearly 30 years. She has been the Executive Director for the Tifton Housing Authority since June 2000. Prior to employment with the Tifton Housing Authority, Shaundra was employed as the Director of

Administration with the Albany Housing Authority.

Shaundra received a Bachelor of Arts degree in Business Administration from Stillman College and a Master of Public Policy and Administration from Mississippi State University. She was designated a National Association of Housing and Redevelopment Officials (NAHRO) Fellow in October 2019 at the NAHRO Annual Conference in San Antonio, TX. Currently, Shaundra is the President of the Southeastern Regional Council of the National Association of Housing and Redevelopment Officials (SERC-NAHRO), which covers 10 states. Locally, she serves on the PLIGHT Board, Ruth's Cottage Board and the Tifton Council for the Arts Board. She is a member of Christ's Church, Rotary Club, and Delta Sigma Theta Sorority.



Patricia Wells - NAHRO National President

Patricia S. Wells was sworn in as President of the National Association of Housing and Redevelopment Officials (NAHRO) in October 2021, and will serve in that position for the next two years.

Patricia Wells brings over 26 years of public administration and nonprofit executive management

experience to her role as Executive Director of the Oakland Housing Authority (OHA). She joined OHA in 1998, following appointments as the Associate Director for Habitat for Humanity International – West Region and Senior Policy Coordinator as a Mayoral appointee with the Department of Consumer and Regulatory Affairs in Washington, D.C. During her current tenure with OHA, Patricia has held key roles in several key initiatives including the reorganization of OHA to a property based property management operation, disposition of 1,610 apartment units and single family homes, a multitude of Moving to Work (MTW) demonstration programs and partnerships, as well as several innovative private/public partnership endeavors. Patricia brings to the OHA leadership team excellent communication skills, stellar inter-governmental and community building expertise, a strong acumen for organization operations and administrative leadership, significant experience as an agent of effective organization change as well as a passion for supporting community led solutions.

In addition to her national leadership role as a member of the National Association of Housing Redevelopment Officials (NAHRO), she is an Soroptimist International of the East Bay Fellow and an active member of the East Bay Regional Parks Foundation, Monterey Bay Aquarium, SF Opera and volunteer of Glide Memorial Homeless Services. Patricia holds a Master's Degree in Public Administration, a B.A in English/Journalism, and several professional certifications.



Mark Thiele - NAHRO Chief Executive Officer

Mark Thiele is a houser who stands in awe of his colleagues. "Safe, stable, affordable housing is the foundation on which we build healthy, happy and productive lives," he says. "Despite significant headwinds, housers nationwide continue to provide the most vulnerable Americans with shelter and supportive services in

sustainable communities. We need to invest in their succees."

Before joining NAHRO, Thiele was the Interim President and CEO of the Houston Housing Authority (HHA). During his tenure, HHA focused on safety, increasing affordable housing, and innovation. The agency hosted numerous COVID-19 testing and vaccination events with local partners. It also added thousands of units of affordable housing through acquisition and development and earning the coveted Moving to Work (MTW) designation.

Prior to that Thiele served as HHA's Senior Vice President (SVP), overseeing Program Operations, Real Estate, Investment and Development, Policy as well as all of the agency's support functions, including Finance, Legal, Procurement, Human Resources and Information Technology. During his time as SVP, Thiele worked with the agency's more than 200 staff members to be the premier provider of quality, affordable housing in Houston.

For the previous eight years of his lengthy year career in affordable housing, Thiele served as the Vice President of the award-winning Housing Choice Voucher Program at HHA, which provides more than \$155 million in housing subsidies each year, and is one of the largest voucher programs in the country. In that role he supervised more than 120 staff dedicated to providing quality, affordable housing options for more than 18,000 Houston households via the regular Housing Choice Voucher, VASH, Mainstream, NED and Mod Rehab programs, as well as a plethora of initiatives funded by the City, County and other entities. The HCVP department played a significant role in Houston's award-winning efforts to end homelessness. Thiele also worked in the affordable housing sector as a consultant at Quadel Consulting Corporation.

Thiele has been a devoted NAHRO member for years, taking on a variety of leadership roles at the state, regional and national levels. At national NAHRO, he served on the Board of Governors, as the Chair of the Board of Ethics and Credentialling Trustees, and as the Vice President of the Community Revitalization and Development Committee. Thiele also served as the Senior Vice President of the NAHRO Southwest Regional Council, and as the President of Texas NAHRO. He is a proud member of the Board of the National Public Housing Museum (NPHM).

Thiele holds a bachelor's degree in Psychology and Anthropology from the University of Texas and a master's degree in International Relations from the University of Chicago.

Capital Fund Program & EPIC

The Capital Fund Program provides funds, annually, to Public Housing Agencies (PHAs) for the development, financing, and modernization of public housing developments and for management improvements. HUD has moved the management of Capital Funds to a more paperless process by using the Energy Performance Information Center (EPIC). PHAs are required to manage their Capital Fund grants in EPIC. These sessions are presented by HUD staff from the Office of Capital Improvements, which oversees the award of more than \$3 billion annually in Capital Funds to PHAs nationwide and the non-formula grants, including Emergency/Disaster Capital Fund Grants, Emergency Safety & Security Capital Fund Grants, Lead-Based Paint Capital Fund Grants, and Housing-Related Hazards Capital Fund Grants. Participants should attend all three sessions covering Capital Fund & EPIC, as each session will build upon the last.

Session 1: Introduction to The Capital Fund Planning Process & EPIC In this breakout session, participants will become acquainted with the Capital Fund planning principles and necessary steps behind the workflows in EPIC. PHAs are responsible for the long-term viability of the PHA and its properties. The Capital Fund plays a pivotal role in financing activities to achieve the PHA's mission and goals as it concerns their public housing properties. Annually PHAs are also required to complete the Capital Fund Submission and planning is a major component, which is largely conducted in EPIC. We will provide an overview of each of the modules in EPIC and explain how they relate to the Capital Fund submission and planning process.

Session 2: Capital Fund Eligible Activities, Reporting Requirements & EPIC In this breakout session, we will also cover different budget line items and which activities are eligible under the Capital Fund and how fulfill the reporting requirements in EPIC. We will review each module in EPIC. For example, we will learn how to submit a document package and the 5-year action plan. Participants will also learn about making revisions to the 5-Year Action Plan and Annual Statement/Budget.

Session 3: Capital Fund Grant Lifecycle & EPIC

In this breakout session, participants will learn about the importance of Capital Fund Obligation, Expenditure, and Fiscal Closeout. We will touch on procurement and contract management. In this session, we will cover additional features in EPIC such as how to use EPIC to exercise fungibility, how to report on RAD transactions, or Debt Service Obligations. We will briefly discuss when and how to submit Performance and

Evaluations Reports, and the newer features available such as Monitoring and Close-out Packages. We will cover how to use EPIC for non-formula Capital Fund Grants, including Emergency/Disaster Capital Fund Grants, Emergency Safety & Security Capital Fund Grants, Lead-Based Paint Capital Fund Grants, and Housing-Related Hazards Capital Fund Grants. Finally, we will touch upon how to request to use Operating Funds for Capital Fund purposes.
