The Albany Housing Authority (AHA) invites qualified architectural firms to submit proposals for professional architectural services related to the renovation of public housing units. These renovations will be funded through the Capital Fund Program (CFP) administered by the U.S. Department of Housing and Urban Development (HUD).

### 2. Project Overview

AHA seeks to modernize and improve the quality of its public housing stock to ensure safe, decent, and affordable housing for its residents. The scope includes comprehensive renovations of multiple housing units, addressing both interior and exterior elements, to enhance livability and compliance with current building codes and standards.

- Detailed fee breakdown by phase
- Hourly rates for additional services

Proposals will be evaluated based on the following criteria:

- Relevant experience and qualifications of the firm and project team
- Understanding of the project scope and objectives
- Proposed approach and methodology
- Past performance on similar projects
- Fee proposal and overall cost-effectiveness
